**Parks Chairwoman Hahn and Legislator Fleming Tour South Fork's County Parks**



SOUTH FORK, NY– Suffolk County Legislator Bridget Fleming (D-Sag Harbor) joined Majority Leader and new Parks & Recreation Committee Chair, Legislator Kara Hahn (D-Setauket), on a tour of County owned parkland on the South Fork. Legislator Hahn

requested the tour that explored Parks Department holdings from Riverside to Montauk as a first step toward fully understanding the scope and needs of County park resources within the Second Legislative District. During their tour, Legislators Fleming and Hahn visited three flagship county parks and acres of preserved open space, including Cranberry Bog County Park, Cedar Point County Park and Montauk County Park.



“Suffolk County’s substantial open space and park land are the natural resources that define our quality of life and make Suffolk unique,” said Legislator Hahn. “This tour of key parks and parklands within Legislator Fleming’s district provided a great opportunity for me to better understand the unique needs of this area and what is required to fulfill our shared commitment to protecting and promoting these incredible resources. Our County parks and beaches have an abundance to offer our residents and tourists.”

In 2012, Legislator Hahn was tapped to serve as chairperson of the Legislature’s Environment, Planning and Agriculture [EPA]. In addition, since January 2017, Hahn has chaired Suffolk’s Parks and Recreation Committee. “Legislator Fleming is an invaluable partner in furthering our mission to preserve and enhance our open space, agricultural land, historical landmarks and our parks throughout Suffolk County. We stand committed to ensuring that our beautiful natural resources are preserved and are able to use by our residents.”
