**RESOLUTION NO. -2019, AMENDING THE 2019 ADOPTED  
OPERATING BUDGET AND TRANSFERRING FUNDING TO  
VARIOUS CONTRACT AGENCIES**

**WHEREAS**, the 2019 Adopted Operating Budget includes funding from Hotel-Motel Tax collections to support the Vanderbilt Museum and the Cultural Affairs Division of Economic Development and Planning; and

**WHEREAS**, the Vanderbilt Museum and the Cultural Affairs Division share a 20% allocation of Hotel Motel Tax collections; and

**WHEREAS**, this legislation allocates adopted hotel motel tax funding to the Vanderbilt Museum and various cultural agencies according to statutory percentages; and

**WHEREAS**, Section 4-31 (G) of the Suffolk County Charter now allows amendment of the County Operating Budget by County Legislators four times during the fiscal year as long as the amendment reduces, lowers, terminates or cancels appropriations; abolishes positions of employment; terminates contract agencies; terminates or reduces the size of County programs or departments, or makes transfers of appropriations that are offset by reductions in other programs; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the 2019 Adopted Operating Budget is hereby amended as follows and that the County Comptroller be and hereby is authorized to transfer the following funds and authorizations.
