**MOTION NO. 22-2019, PROCEDURAL RESOLUTION

2nd **RESOLVED**, that the Presiding Officer and Clerk of this Legislature be authorized to execute and deliver to the County Comptroller a warrant of this Legislature directing him to make the payments therein specified in the report in accordance with the provisions of Section 261 of the Tax Law; and be it further

3rd **RESOLVED**, that this Procedural Resolution shall supercede Procedural Resolution No. 20-2019 in its entirety.
