

**RESOLUTION NO. 553 -2020, AUTHORIZING THE SALE OF
TAX LIEN CERTIFICATES ON 344 MERRICK ROAD,
AMITYVILLE, NY (SCTM NO. 0101-008.00-04.00-010.000) TO
THE SUFFOLK COUNTY LANDBANK CORPORATION**

WHEREAS, Local Law No. 18-2012 authorized the County to establish the Suffolk County Landbank Corporation (“Landbank”); and

WHEREAS, the Landbank’s mission is to efficiently facilitate the return of distressed and underutilized properties within Suffolk County to productive uses consistent with the comprehensive plans of the jurisdictions in which they are located; and

WHEREAS, the Landbank is specifically charged with the goal of reducing the number of properties that are both tax delinquent and environmentally challenged within Suffolk County; and

WHEREAS, since its inception the Landbank has identified over 160 properties which are both tax delinquent and potentially environmentally challenged, all of which represent an ongoing cost to the County; and

WHEREAS, the Landbank conducts exhaustive due diligence efforts on all potentially contaminated tax delinquent properties including Phase I and Phase II Environmental Site Assessments (“ESA”) as appropriate on an ongoing basis to identify properties suitable for potential sale and redevelopment; and

WHEREAS, the Site located at 344 Merrick Road, Amityville, NY (SCTM No. 0101-008.00-04.00-010.000), has been tax delinquent since the year 1996 with tax liens, interest, and penalties totaling over Five Hundred Ten Thousand, Six Hundred Seven Dollars (\$ 510,607) Dollars; and

WHEREAS, 322 Merrick Rd Realty, LLC proposes to pay (\$100,000) for the tax liens on the site with the intention to rehabilitate and remediate the site; and

WHEREAS, at its July 14, 2020 meeting, the Landbank Board of Directors approved the acquisition and disposition of the liens associated with this Site from the County for the negotiated sale and assignment to 322 Merrick Rd Realty, LLC or an authorized designee pending the approval of the Legislature; now, therefore be it

1st **RESOLVED**, as authorized by Sections 1608 and 1616 of the New York State Land Bank Act and notwithstanding Suffolk County Resolution Nos. 936-1972 and 1010-1972, the County hereby authorizes the sale of all liens for 344 Merrick Road, Amityville, NY (SCTM No. 0101-008.00-04.00-010.000), to the Suffolk County Landbank Corporation at a nominal value not to exceed \$1 per tax lien; and be it further

2nd **RESOLVED**, the Suffolk County Comptroller is hereby directed to assign all liens for the aforementioned properties to the Suffolk County Landbank Corporation; and be it further

3rd **RESOLVED**, the Landbank shall dispose of said liens to 322 Merrick Rd Realty, LLC or an authorized designee for an amount not less than \$100,000 to be paid directly to the Landbank; and be it further

4th **RESOLVED**, upon request of 322 Merrick Rd Realty, LLC or an authorized designee the Suffolk County Comptroller is hereby directed to perform an administrative foreclosure and issue fee simple title to 322 Merrick Rd Realty, LLC or an authorized designee for the Site (SCTM No. 0101-008.00-04.00-010.000); and be it further

5th **RESOLVED**, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), N.Y. Environmental Conservation Law Article 8 and Chapter 450 of the Suffolk County Code, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(26) and (33) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS ("NYCRR") in that the action constitutes routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment. The Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
