A motion was made by Mr. De Rubeis to approve the February 19, 2020 minutes. The motion was seconded by Ms. Kepert. Motion carried.

A motion was made by Ms. Spencer to approve the February 26, 2020 minutes. The motion was seconded by Ms. Spilka. Motion carried.

**Correspondence:**

John Corral, staff to the CEQ, noted that the CEQ received correspondence from Royal Reynolds on the Suffolk County Subwatersheds Wastewater Plan approximately two and a half weeks ago and that CEQ staff forwarded said correspondence on to the CEQ members at that time. Mr. Gulbransen noted that the CEQ would keep this correspondence on file but there is not an action warranted for this CEQ to take regarding this letter at this time.

Mr. Gulbransen noted that he received correspondence from CEQ Member Michael Doall indicating his need to resign from the CEQ. A motion was made by Larry Swanson to accept Mr. Doall's resignation. The motion was seconded by Mr. DeRubeis. All CEQ members presented voted in favor and the motion carried to accept resignation.

Director's Report:

Housing agreements:

Mr. Martin noted that a tenant has moved into the Cottage at Blydenburgh Park in Smithtown. The resolution IR 1283-2020 approving the tenancy of this individual at the Cottage at Blydenburgh Park is included on the LADS Report. Mr. Martin also noted that Suffolk County Parks had done an upgrade of interior prior to the tenant moving into the cottage.

There are quite a few custodial agreements that have expired at historic sites and contracts. Mr. Martin noted that the Suffolk County Parks Contract Division is working to complete the extensions of these contracts.

**Recommended Unlisted Actions:**

A. Proposed Improvements to CR 16, Horseblock Road, in the Vicinity of Brookhaven Waste Management Facility to CR 56, Victory Road, Town of Brookhaven

In a presentation by Erik Bergey, Senior Civil Engineer, Suffolk County Department of Public Works provided an overview of the project. Mr. Bergey noted that the consultants for the project were also present to any questions that may come up. It was noted that the proposed project involves safety and mobility improvements including: reconfiguring the intersections of CR16/CR21 and CR 16/CR 56, widening the shoulder on CR 16 from east of CR 99 to CR 56, and on CR 21 from CR 16 to north of Mason Street, and constructing ADA-compliant pedestrian accommodations along the north side of CR 16 and west side of CR 21. It was also noted that the safety and mobility improvements also include providing traffic signal improvements to the intersection of CR 16 and the Town of Brookhaven Landfill as well as road signage and striping. The proposed project will also improve drainage through the cleaning of existing drainage structures and the construction of new drainage infrastructure along CR 16 as well as improvements to the two existing recharge basins at the intersection of CR 16 and CR 21.

The CEQ had questions regarding whether there was a need for adding a sidewalk in the area. Mr. Bergey noted that there are some residential uses and commercial uses in the area that may result in a need for the sidewalk. The CEQ also had a question whether a bike lane would be added. It was noted that there is space on the shoulder for a bike lane but there is not plan to add a painted bike lane at this time.

A motion was made by Mr. Kaufman to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. The motion was seconded by Mr. De Rubeis. Motion carried.

B. Proposed New Addition to the Suffolk County Police Property Bureau Building, CP 3514, Yaphank, Town of Brookhaven

In a presentation by Paul Clinton, Architect, with Suffolk County Department of Public Works, it was explained that the project consists of an approximately 16,000 sf warehouse and storage space addition to the existing Suffolk County Police Property Bureau Building. The building is located just west of County Road 21 and south of the Long Island Rail Road Tracks at the Suffolk County Yaphank County Complex. The addition would be a one story addition with a new mezzanine storage vault.

A motion was made by Mr. De Rubeis to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. The motion was seconded by Ms. Spilka. Motion carried.

C. Proposed Acquisition of Land Under the New Suffolk County Drinking Water Protection Program – Hamlet Park/Historic Park and/or Cultural Park Component – For the Lawrence Simms Property, Town of Riverhead

In a presentation by Melissa Kangas, Planner, with the Suffolk County Department of Economic Development and Planning. It was explained that the project involves the acquisition of land by Suffolk County under the New County Drinking Water Protection – Hamlet Park/Historic Park and/or Cultural Park Component – For the Lawrence Simms Property, Town of Riverhead. The proposed acquisition is located south of the intersection of West Main Street and Kroemer Avenue in the hamlet of Calverton, Town of Riverhead (SCTM #s 0600 11900 0200 056000, 0600 11900 0200 057000 and 0600 11900 0200 058000). It is proposed that the Town of Riverhead would improve and maintain the park in perpetuity and access to the park will be provided to all Suffolk County residents. The proposed improvements (as indicated by the Town Concept Plan attached to the EAF) include a parking area, gravel walking path and wildlife viewing area along the Peconic River.

It was also noted that the proposed acquisition was a former duck farm and that there are a number of structures that still exist. It was stated during the presentation that it will be the responsibility of owner of the property to remove the structures before the property is acquired by the County. It was also clarified that it will also be the responsibility of the landowner to complete the environmental cleanup that needs to occur on the property and that the Suffolk County Department of Health Services will be involved in the review of this environmental clean-up.

A motion was made by Ms. Keper to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. The motion was seconded by Mr. De Rubeis. Motion carried.

Resolutions Laid on the Table March 17, 2020. The motion was seconded by Ms. Kepert. Motion carried.
