New York Governor Hochul has signed S.50001/A.40001 which allows requirements of the State's Open Meetings Law to be waived through January 15, 2022. Therefore, beginning with the September 27, 2021 committee cycle and continuing through the end of the year, the Legislature will revert to the rules of operation that were adopted via procedural motion in March of 2020.

As such, this Legislature will be conducting meetings in a hybrid fashion and allow in-person public attendance and in-person public portion comment at the William H. Rogers Legislature Building or remote testimony via Zoom. For both options, speakers will be limited to 3 minutes.

In accordance with county and state COVID-19 safety protocols and current CDC recommendations, members of the public will be required to wear a mask at all times while inside the building.
