## **NOTICE TO RESIDENTS** **APRIL 2022**

The Suffolk County Department of Public Works has entered into a contract with GGG Construction Corp., for Pedestrian Safety Action Plan (PSAP), Various Signalized Intersections, County Wide, Towns of Babylon, Brookhaven, Huntington Islip, Riverhead, Smithtown and Southampton. The work will consist of installing pedestrian signals with countdown timers, pedestrian pushbutton assemblies with associated signs, high visibility crosswalk markings, and replacing any affected curb ramps with PROWAG/ADA compliant ramps. The work proposed under this project is intended to improve overall pedestrian safety at these intersections while at the same time bringing them into MUTCD and PROWAG/ADA compliance.

Within the next several weeks, construction crews will be laying out boundaries in preparation of this work. ***Please remove all landscape and hardscape items (i.e.: plants, shrubs, fences, sprinklers, stones, signs, chairs, etc.) between the existing roadway and the highway boundary (County right-of-way). Items remaining within this area will be removed and disposed of and will not be replaced.***

*If you have intentions to pursue upgrading any underground utilities emanating from the roadway limits, such as gas or water service, or an underground electric service, please contact the respective utility at this time to ensure that the installation is completed **AS SOON AS POSSIBLE**. The County **WILL NOT** allow any pavement disturbance for five years after completion of the roadway construction.*

There may be parking restriction and/or lane shifts during the course of this project. ***Information will be posted the night before they will be enforced.*** The anticipated completion of this project is Spring 2023.

During construction, please keep this area clear of vehicles from 7:00 a.m. to 3:30 p.m. Monday through Friday. Two way traffic and access to adjacent property will be maintained at all times.
